Hail Cat 2026 Breeding Contract

This STALLION BREEDING CONTRACT for the **2026** breeding season is entered into on this date:

_____ day, of _____ 20____, is by and between Meyer Quarter Horses,
hereinafter designated Breeder, and _____, hereinafter designated
Mare Owner. Mare Owner agrees to breed the Mare _____

Reg. No: _____ to the Stallion, **Hail Cat**, for the breeding fee
of **\$1250** for a live foal, subject to the following conditions.

- The breeding fee includes a non-refundable booking fee of **\$500.00**, payable upon execution of this Stallion Breeding Contract for the **2026** breeding season. The remaining balance, together with all additional expenses, must be paid in full prior to shipment or breeding of the mare. Mare Owner may not remove mare from Breeder's possession until all expenses are paid in full. If mare owner is using shipped semen, all payments for shipped semen and collection/chute fees must be made with Outback Stallion Station before any semen is shipped. Collection days are: **Monday, Wednesday, Friday** starting **February 2** through **June 30**. Semen must be requested to Outback Stallion Station by 4:00 pm MST the day prior to the necessary collection day and canceled/confirmed by 8:00 am MST the day of the collection. *All efforts will be made to send cooled semen unless frozen is requested or said stallion is unavailable due to his showing schedule.*
- The Outback Stallion Station semen shipping container must be returned and received by the Outback Stallion Station within 7 days of received shipment or \$25 per day late fee will be charged. A fee of \$50 will be assessed if the container is not returned to the Outback Stallion Station.
- Breeder will exercise judgment consistent with recognized standards in care and supervision on mare/or foal. Breeder's veterinarian will examine mare for normal breeding conditions and administer medical care as deemed necessary for the health and safety of the mare and/or foal. All veterinarian expenses will be taken up with Outback Stallion Station if mare is bred at the stallion station facility.
- The mare shall be in healthy and sound breeding condition, free from infections, contagious or transmissible disease. Mare must have a current negative Coggins test and copy of registration papers if mare is taken to Outback Stallion Station.

- Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, Mare Owner will hold Breeder or stallion station blameless. It will be up to the Mare Owner to have the mare ultra-sounded by a licensed veterinarian or trained technician 14-16 days after being bred. The results should be reported to the Outback Stallion Station and Breeder. Any mare not ultra-sounded 14-16 days after being bred will make the "Live Foal Guarantee" null and void.
- This contract contains a "Live Foal Guarantee." A live foal is described as a newborn foal, which stands and nurses without assistance. If foal is born dead, there are return privileges for the following breeding season only if Breeder is notified within 7 days and received a veterinarian's certificate describing the occurrence. If a mare, deemed "safe in foal," subsequently miscarries, aborts, or is found barren after leaving the Breeder's premises, the Mare Owner may return her for breeding within the following season (February to June 30) or in 2027. There will be a fee of \$405 per collection/shipment per rebreed assessed along with additional shipping if requesting counter-to-counter or same day shipment.
- The "Breeders Certificate" will be issued for the foal, conceived by this mating, when breeding fee and all other expenses have been paid in full; when mare has produced a live foal by this mating. Owner must contact the Stallion owner when mare foals.
- Both parties agree that the Meyer Quarter Horses, the Breeder, their agents or employees are not liable for death, sickness and /or accidents including consequential damages caused to the stallion. Every attempt will be taken to deliver cooled semen to mare owner in good condition, however once the shipment leaves the Outback Stallion Station, Meyer Quarter Horses and/or the Outback Stallion Station cannot be held responsible for delayed arrival or condition of semen upon arrival to Mare Owner.
- It is further agreed that should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare that the breeding fee transfers for Meyer Quarter Horses, if it is paid in full. If the mare dies or becomes unfit to breed before pronounced safe in foal, the Breeder will accept another mare upon approval. However, should mare die after being pronounced safe in foal, the "Live Foal Guarantee" will be null and void.
- This Contract is non-assignable. Breeder strongly recommends Mare Owner carry full insurance on mare and/or foal. This contract is entered into the State of North Dakota, will be interpreted, and enforced under the laws of the state.
- This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in the Written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties.

- The breeding fee costs are as follows: **\$1250** breeding fee (new contract) plus **\$405** collection, chute fee and shipping fee (next day via FedEx) and additional shipment costs for same day Counter to Counter Airline shipping. ***If shipped semen is requested or cooled is unavailable due to stallion's showing schedule, the shipping fee will be **\$450 for frozen and 48 hours notice** is needed. There is a **multiple mare discount of \$1000 per mare for a single mare owner** and will be stated as such in the contract.
